## Notice of Proposed Property Tax Increase for

## Toulon Public Library District

- II. The corporate and special purpose property taxes extended for 2023 were \$285,877.23
  - The proposed corporate and special purpose property taxes to be levied for 2024 are \$335,000. This represents a 17.18% increase over the previous year.
- III. The property taxes extended for debt service and public building commission leases for 2023 were \$0.
  - The estimated property taxes to be levied for debt service and public building commission leases for 2024 are \$0. This represents a 0% increase over the previous year.
- IV. The total property taxes extended for 2023 were \$285,877.23. The estimated total property taxes to be levied for 2024 are \$335,000. This represents a 17.18% increase over the previous year.
